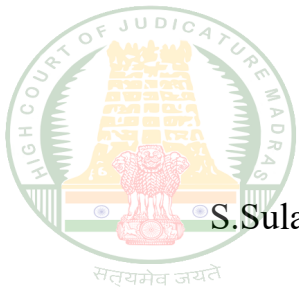

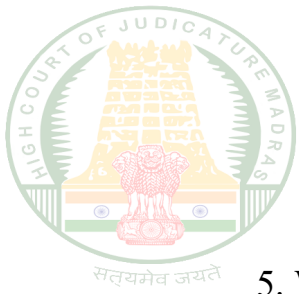

ORDER

This Civil Revision Petition has been filed seeking a direction to the learned I Additional Subordinate Judge, Coimbatore to expedite the hearings and dispose of LAOP No.255 of 2021, within a time frame, fixed by this court.

2. The petitioner herein is the 3rd claimant in the above LAOP. A perusal of the remarks submitted by the learned I Additional Subordinate Judge would indicate that there are 65 claimants in the above LAOP and merely 25 claimants have not filed claim statements. It is also seen from the remarks that some of the claimants are died and substitution petitions are pending.

4. Taking into consideration that the LAOP was of the year 2021 and some of the claimants have not filed their claim statements, even after a lapse of 5 years, this court is inclined to direct the learned I Additional Subordinate Judge, Coimbatore to dispose of the LAOP No.255 of 2021 as expeditiously as possible.
