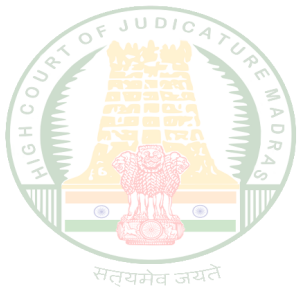

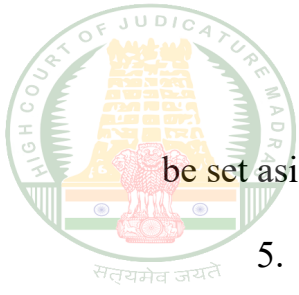
ORDER

This Civil Revision Petition has been filed seeking to set aside the Order passed in IA.No.1 of 2024 in IA.No.395 of 2017 in OS No.77 of 2015 dated 03.09.2025 on the file of District Munsif Court Mettur, salem.

2. The respondents herein filed IA.No.1 of 2024 in IA.No.395 of 2017 in OS No.77 of 2015 on the file of District Munsif Court Mettur, Salem, seeking to scrap the Commissioner report and to appoint a new Advocate Commissioner in order to re-visit the suit property along with the help of an qualified surveyor and to measure the same and to file a detailed report with plan. Upon hearing both sides, the Trial Court allowed the said application stating that the Commissioner report is no sufficiently disclosed about the measurements of the suit property or the petitioners property.

3. Aggrieved over the same, the petitioner filed this Civil Revision petition.

4. The learned counsel for the petitioner submits that the petitioner filed the suit for bare injunction but in order to drag on the suit proceedings the respondents filed the said application. However, without considering the above facts, the Trial Court allowed the application as such is erroneous and liable to



be set aside.

5. The Trial Court order reflects that the earlier Advocate Commissioner has not followed the memo of instructions given by them but for that reason alone the report need not be scrapped.

6. Admit. Issue notice to the respondents returnable by 07.07.2026. Private notice is also permitted. Post the matter on 07.07.2026, till then, order passed by the District Munsif Court Mettur, salem IA.No.1 of 2024 in IA.No.395 of 2017 in OS No.77 of 2015 is ordered to be stayed.

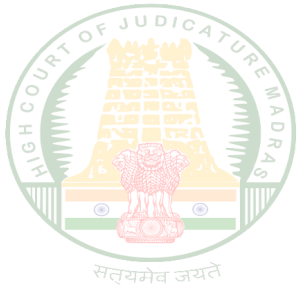
