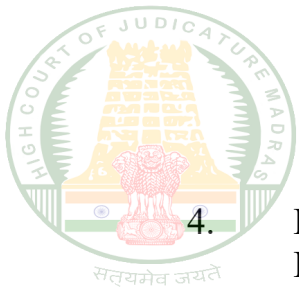

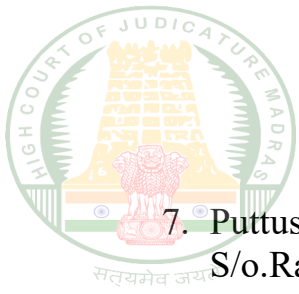

2.Mr.R.Rajadurai, Counsel on record for the Petitioners is before this Court.

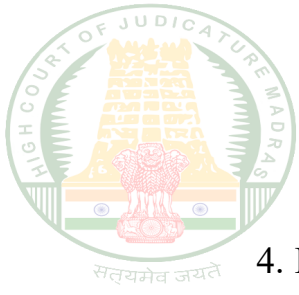
