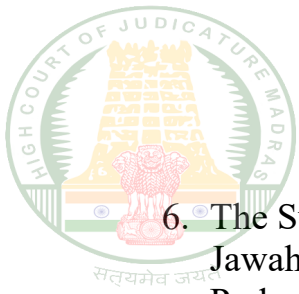

ORDER

Heard the learned counsels appearing on either side.

2. The learned counsel for the petitioner submitted that the petitioner's Aalaya Vizhakkuzhu has filed the present Writ Petition as against the "No Objection Certificate" dated 07.08.2024 and "Building Permission" dated 28.02.2025 granted by the second and third respondent respectively in favour of the seventh respondent Church herein and further submitted that the case has been admitted and an order of status quo has been granted by this Court on



17.02.2026, whereas the learned counsel for the seventh respondent Church submitted that the third respondent has granted planning permission on 28.02.2025 in favour of the seventh respondent and almost 90% of the work was completed and the respondents 2 & 3 has yet to inspect the subject Church premises.

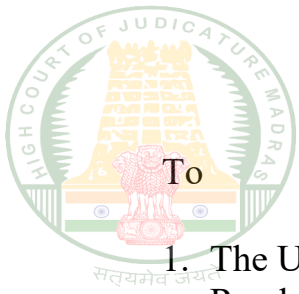

In view of the submissions made by the parties concerned, this Court directs the official respondents to file a report clarifying the points, namely, a) whether the construction was done as per the planning permission granted to the seventh respondent or not ? and b) whether the zone of construction of Church is a worship place or a residential place ?
