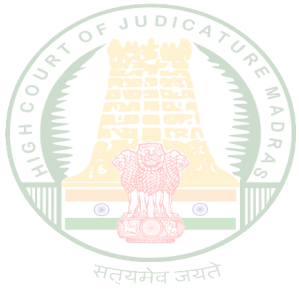
COMMON ORDER
