**ORDER**

This application has been filed to implead the applicants as proposed defendants 6 and 7 in the present suit C.S.No.899 of 2004.

2. Applicants / parties – in – person are present. Learned counsel for R1 to R3 / plaintiffs is present and has filed his counter and the learned counsel for R8 / D5 is present and has filed his counter and the learned counsel for R4 / D1 submits that she has got no objection in allowing this application and has made an endorsement to that effect. However, during the course of hearing, it is felt that that this matter is a fit case for referral to mediation enabling the parties to explore the possibility of amicable settlement if any, in a time bound manner and all the parties conceded the same.

3. Accordingly, this matter is referred to mediation and the all the parties to the suit as well as the applicants herein, pending this application, shall participate in the mediation in order to arrive at a mediated settlement. However, it is made clear if the mediation has failed, the matter shall be sent back to court and having already heard all the parties, this application will be decided on merits.

4. As chosen by the learned counsels for both parties as well as the applicants /

parties – in – person in this application, the Director of the Mediation Centre shall appoint Mrs.Chitra Sampath, learned Senior Counsel, Mr.B.Ullasavelan and Mr.C.Ramesh as mediators subject to Rules. All the parties including the applicants / parties – in – person in this application, along with their respective learned counsels, are directed to appear before the Mediator(s), Tamil Nadu Mediation and Conciliation Centre, High Court of Madras on 20.07.2026 and the Mediator(s) shall hold appropriate sessions with the parties, explore the possibility of an amicable settlement of the inter se disputes, and facilitate the parties in arriving at a mutually acceptable resolution and the mediator(s) shall send an interim report stating the progress of mediation on or before the next hearing date.

5.Registry is directed to list the matter on 21.08.2026 along with the mediation report under the caption ‘Mediation referred cases’.
