ORDER

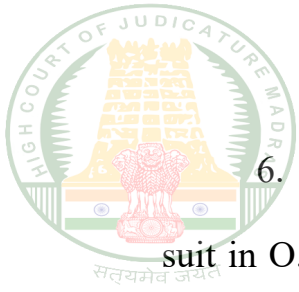

5. Post on 24.03.2026.



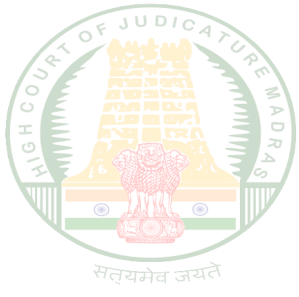
