2. The Trial Court is directed to issue instructions to the Advocate Commissioner to file the report within a period of two weeks from today.

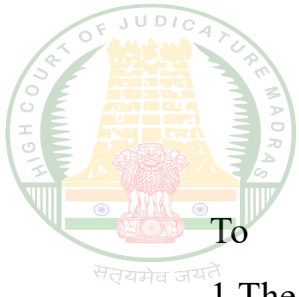
