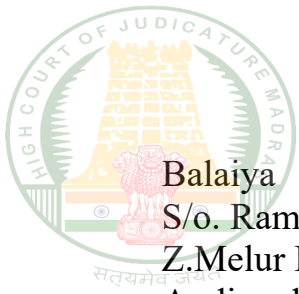

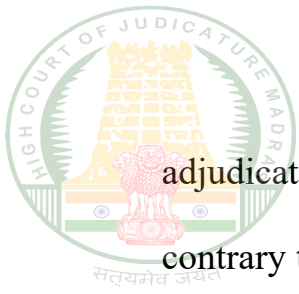

ORDER

Challenging the Judgement and Decreetal order dated 17.06.2025 made in IA No.4 of 2024 in OS No.133 of 2024 on the file of Special Court No.2 Jayankondam, Ariyalur District, the plaintiffs have filed the present Civil Revision Petition.

2. The learned counsel for the petitioner would submit that the reliefs sought in the suit in O.S. No.133 of 2025 are not one and the same as of earlier suit in O.S. No.832 of 1981. However, the Trial Court has held that the plaintiffs in O.S. No.133 of 2025 being legal heirs are bound by earlier



adjudication and the same operates as constructive resjudicata is wrong and contrary to law. is wrong, when the reliefs claimed thereon are not one and the same. Further, its findings that the suit in O.S. No.133 of 2025 does not reflect a different cause of action as same is wrong and contrary to the facts of the case. Hence, he seeks to set aside the order dated 17.06.2025 made in IA No.4 of 2024 in OS No.133 of 2024 passed by the Trial Court.
