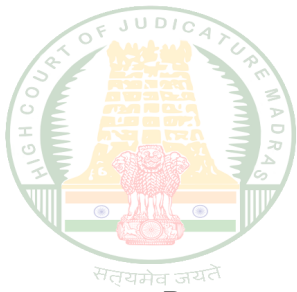

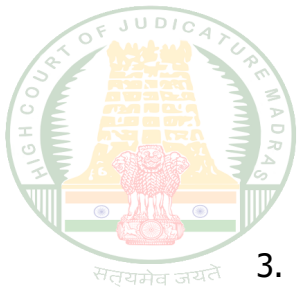

(Order of the Court was made by R.Suresh Kumar J.)

The impugned order dated 29.07.2025 made in W.P.No.27467 of 2025 has been passed by the writ court fully following an earlier order passed by this Court in W.P.Nos.18580 and 21291 of 2023 dated 24.04.2024.

2. The said order also, though had been appealed by filing a writ appeal in W.A.No.559 of 2025 by the State, in the meanwhile the order dated 24.04.2024 had been complied with, without prejudice to the rights of the appellant in the said appeal. This in fact has been recorded by an earlier Division Bench in W.A.No.559 2025 by an order dated 30.04.2025 to the following effect.

" It is stated that the order dated 24.04.2024 has been complied with subject to the result of the appeal."

3. The said appeal is also pending before this Court. In that view of the matter, there shall be a direction to the appellants to comply with the present impugned order also in the light of the earlier compliance made pursuant to the order in W.P.Nos.18580 and 21291 of 2023 dated 24.04.2024, within a period of four weeks from the date of receipt of a copy of this order. Such a compliance shall be subject to the outcome of the present appeal as well as W.A.No.559 of 2025.

4. Post this writ appeal along with W.A.No.559 of 2025. It is made clear that, merely because the compliance is made by the appellants now during the pendency of this appeal, no equity or advantage can be claimed by the writ petitioner at the time of final hearing of the writ appeal.
