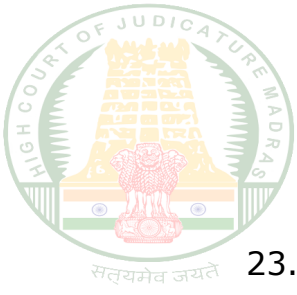

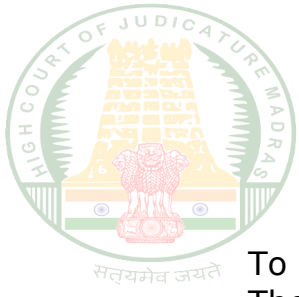
23.11.2021 on the ground that the suit itself namely O.S.No.18 of 2013 on the file of the Additional District & Sessions Court, Dharmapuri was dismissed for default on 01.8.2016. While passing the said order dated 23.11.2021, this Court made it clear that in case the said suit happened to be restored back to file, the petitioner could prosecute the above civil revision petition by filing a restoration petition.

4. It is brought to the notice of this Court that the suit has been restored on 11.6.2025 and hence, CMP.No.1491 of 2026 came to be filed to restore the civil revision petition to file and hear the same on merits. This Court is satisfied with the reasons assigned in the affidavit filed in support of CMP.No.1491 of 2026.

5. Accordingly, CMP.No.1491 of 2026 is allowed and CRP.No. 1264 of 2016 is restored back to file. **Post the civil revision petition for final hearing on 14.8.2026.**
