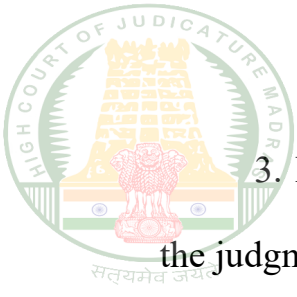

ORDER

Mr.Anirudh A. Sriram, learned counsel submitted that he is appearing on behalf of the judgment debtor.

2. This application has been filed pursuant to the orders passed by this Court on 12.12.2025. This Court had directed the judgment debtor to file an affidavit of assets in Application No.4351 of 2025 and the same was not complied with. In view of the same, the award holder has sought for arrest of the judgment debtor and for detention in the Civil Prison.



3. In the considered view of this Court, the award has become final and the judgment debtor has also not chosen to file the affidavit of assets. Therefore, the judgment debtor has to necessarily comply with the award and it is submitted that as on date a sum of Rs.7.8 crores is payable by the judgment debtor to the award holder. If the judgment debtor does not come up with proper proposal for settlement of the amount, this Court will proceed to pass final orders in this application.

4. The learned counsel for the judgment debtor submitted that the judgment debtor had made some payments to the award holder. In such a case, a memo of calculation shall be filed before this Court to ascertain the amount that has been paid by the judgment debtor.

5. Post this application under the caption for orders on 13.02.2026. Registry is directed to delete the name of Mr.U.Karunakaran who appeared for the judgment debtor and the name of Mr.Anirudh A.Sriram shall be printed in the cause list.
