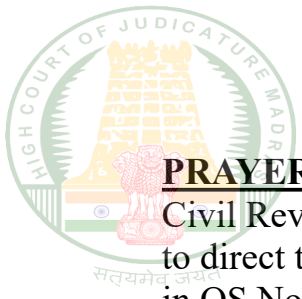

2. Heard, Mr.R. Lakshmi Narayanan, learned counsel for the petitioner, and perused the materials available on record.

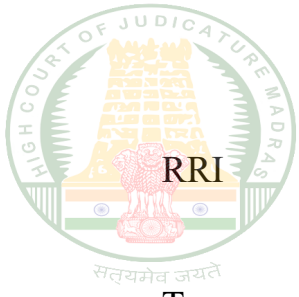
