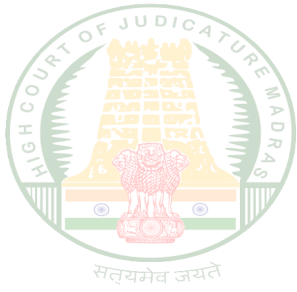

This appeal has been filed to set aside the Judgment and Decree dated 19/01/2017 made by this Court in C.S No. 214/2009.

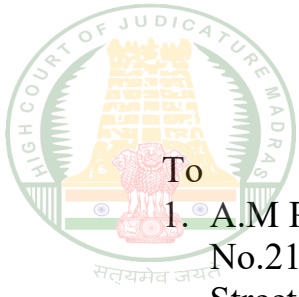

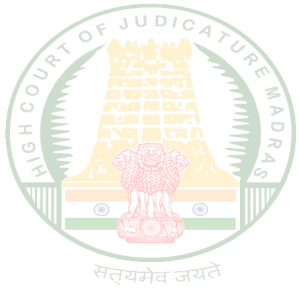
