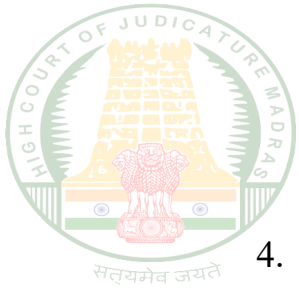

Mr.M.K.Kabir, learned Senior Counsel, has been appointed for mediating this case is not in the Mediators' panel and this Court is called upon to fix the fees for mediator.

2. The learned Counsel for both sides submit that the regular fees that is fixed for all the mediators who are in the mediation may also be fixed for this mediator. However, this Court is of the opinion that as such the present fee structure for mediators is pretty low and hence, the same has to be enhanced and in this view of the matter, this Court is inclined to fix the mediators fee.

3. Considering the number of sessions that were conducted and fruitful settlement has been arrived at between the parties, this Court fixes the Mediator's fees at Rs.15,000/- and the parties are equally share among themselves and make the payment to the Mediator, Mr.M.K.Kabir, learned Senior Counsel and submit the necessary report before this Court on or before 17.04.2026.
