The learned counsel for the Plaintiff is present. There is no representation for the Defendants. Upon perusal of the plaint, the written statement of the second Defendant and draft issues filed by the Plaintiff, the following issues are framed:

(1) Whether the Plaintiff is entitled to a partition of the suit schedule property by metes and bounds and for the allotment of 1/3rd share in the suit property?

(2) Whether the Plaintiff is entitled to a declaration that the Settlement Deed dated 20.06.2013, which is registered as Document No.2192 of 2013, on the file of

the Sub Registrar, Kodambakkam is illegal null and void?

(3) Whether the Plaintiff is entitled to a declaration that the Settlement Deed dated 10.02.2016, which is registered as Document No.837 of 2016 on the file of the Sub Registrar, Kodambakkam is illegal null and void?

(4) Whether the Plaintiff is entitled to a permanent injunction restraining the Defendants from alienating or encumbering the suit schedule property?

(5) Whether the parties are entitled to any other relief?

2. Post the matter before the Additional Master-II on 10.02.2020 for recording evidence. The parties are directed to complete all prior procedures such as filing of list of witnesses and affidavit of documents prior to that date. The learned counsel for the Plaintiff is permitted to apply for and obtain copies of documents filed by the Defendant along with the written statement.
