2. A.No.6629 of 2023 has been filed to extend the tenure of Interim Management Committee for a period of six months or until disposal of OSA Nos. 36 to 40 of 2022 by the Division Bench, whichever is earlier. The Application is ordered in terms of the prayer sought for.

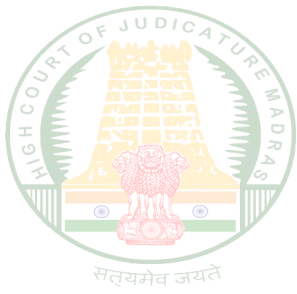
3. A.No.6711 of 2023 filed seeking permission for receiving of documents already set out in the schedule to the written statement is ordered as prayed for.

4. A comprehensive report dated 24.11.2023 is filed by the learned Judge Commissioner which is taken on file and made part and parcel of the record.

5. As regards the directions that have been sought by learned Judge Commissioner, the following suggestions are made:-

(i) to construct additional rest rooms, and first aid rooms for the students and providing clean ORWO water facility in all the schools.

(ii) to undertake construction of the auditorium and additional class rooms by construction of additional block in the college premises and the canteen therein. To provide solar panel facility in SMD Vidyashram, to upgrade in SMD

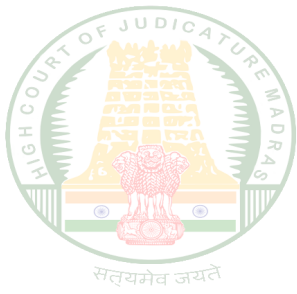
College and SMD Higher Secondary school.

Since the forensic audit is expected to be completed only after 30.12.2023, let the report be obtained within four weeks thereafter i.e., on or before 31.01.2024. Once the ground position i.e., income and expenditure / receipts and payments is ascertained, further directions will be issued in regard to construction of rest rooms, auditorium and other required work.

(iii) to direct the Commissioner of Police Chennai City to remove the seized vehicle parked there in the college and SMD Vidyashram School premises, Kodingayur Chennai.

In order to facilitate the removal of seized vehicles, Commissioner of Police, Greater Chennai, Vepery, Chennai - 07 is suo motu impleaded as respondent no.16 and Mr.P.Anandakumar, learned Government Advocate, accepts notice. A direction is issued to the Commissioner of Police, Greater Chennai, Vepery, Chennai - 600 007, to remove the seized vehicles parked in the College and in SMD Vidyashram School within two weeks from today and clean the place thoroughly.

(iv) to direct the banks and the Tamil Nadu Transport Development Corporation

to effect name change in the FDs to have the deposits in the name of the Sri Muthukumaraswami Devasthanam educational society reflecting the PAN number of the society.

(v) And to get the regularization of the second floor in SMD Vidyashram by the CMDA.

As far as the directions sought in (iv) and (v) are concerned, let the needful be done by way of application by the Interim Management Committee to the concerned authority. Further directions will be issued as and when necessary.

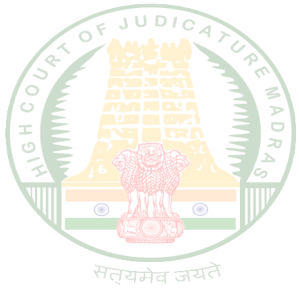
