ORDER

Mr.Bharanidharan may collect the Reports of the Hon'ble Judge Commissioner from the Bench Officer, take adequate copies and circulate the same to Mr.Singaravelan, Mr.Raghavachari and Mr.Pappiah, learned Senior Counsel, and return the originals to this Court by Tuesday i.e., 19.08.2025.

2. The issue relates to co-option of 5 members from the general Body of the Society to constitute the governing Body, as required under Clause 11 of the 1987 Bye-Laws. It appears that only 3 out of the 5 trustees have co-opted the 5 members and the choice of the 5 co-opted members is objected to, by two trustees, who are now before the Court.

3. Perhaps a proper interpretation of Clause 11 might be to ensure that



the co-option of the members is unanimous, by all the 5 trustees.

Mr.Raghavachari wishes to respond to this suggestion and also to present other

methods by which the co-option may be made in a democratic manner.

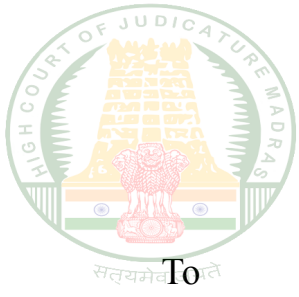

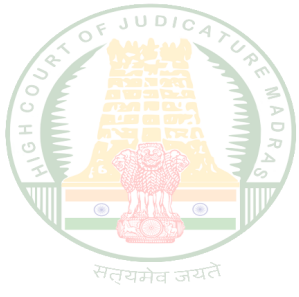
