Interim Report dated 10.02.2022 of the learned Judge Commissioner is placed on file. Let a copy thereof be supplied to all learned counsel appearing in the matter.

2. Specific orders of this Court are sought in regard to the following issues:

- 'a) Break open the houses where the notices sent are returned with endorsement "Door locked" (3 Nos.), houses covered under the details "Notices returned with endorsement "no such person" (52 Nos.), "unclaimed" (9 Nos.), "addressee left" (14 Nos.) apart from this to take against the inmates occupying the houses where notices were return to the endorsement as licensee "reported dead";*
- b) Direct the family members of the deceased erstwhile senior trustee S.Muthu to handover keys of the safe vault without delay;*
- c) Direct the District Registrar, Societies Chennai-600 001 to issue the details for reviving the 1979 Educational Society;*
- d) To carry on minor repairs of white washing and plastering of the wall and floor wherever required in the vahana mandapams;*
- e) To carry out minor repairs to the Vahanams through donors pertaining to both the temple owned Vahanams and Kattalai vahanams;*
- f) Direct the Educational Institutions to furnish details as sort for letter dated 10.01.2022;*
- g) To permit the interim committee to finalise the firm as regards installation of Cameras through donors.'*

3. The learned Judge Commissioner may, with the assistance of the interim

committee, carry out all tasks as necessary to give effect to the orders of this

Court dated 22.03.2021 / 21.10.2021. Thus, as regards (a), (b), (d), (e), (f) and



(g) above, no specific orders are required.

4.As far as item 'c' is concerned where a direction is sought to the District Registrar of Societies, learned counsel who appears for the aforesaid officer is directed to co-ordinate with the officer to ensure full compliance with the direction of this Court.

5.Mr.R.Shanmugam, learned counsel conveys that some of the members of the community have expressed difficulty in contacting the Chairperson and communicating their views in the matter.

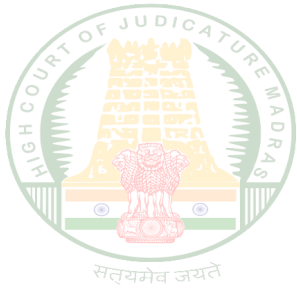
