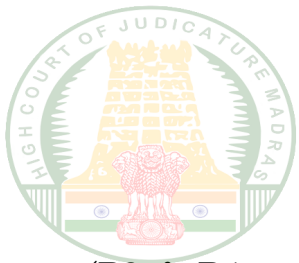

Prayer in WP(MD). 27352/ 2019 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court Directing the respondents for grant of pensionary benefits with other consequential benefits including monthly pension along with interest for the service rendered by the petitioner for the period from 25.7.1980 to 29.12.1998 for 19 years in the light of the Judgment of this Honourable Court in WP(MD).No.461 and 106/2013 dated 2.3.2015 which was confirmed by the Division Bench of this Honourable Court by order dated 4.7.2017 and the dismissal of the SLP filed by respondent before the Supreme Court on 19.2.2018 and the same was complied by the respondent in terms of G.O.Ms.No.115 Transport Department dated 27.11.2018.
