3.Since a civil suit regarding title is pending and that the same appears to be a third round of litigation, the order of the learned Single Judge



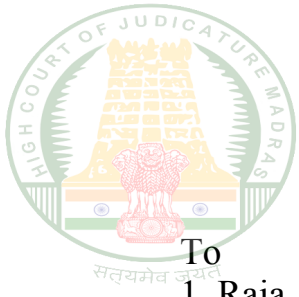
directing the Revenue Divisional Officer to conduct enquiry regarding issuance of patta, if allowed, may complicate the issue pending before the competent civil court.
