Let the Commissioner's report be filed by the Commissioner in this case.

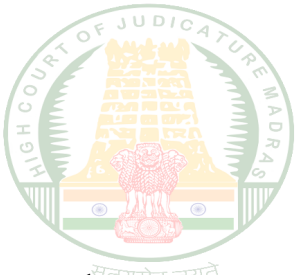
