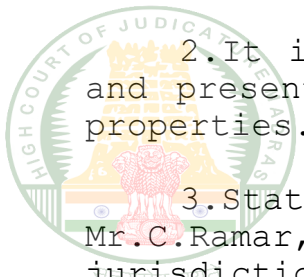

3.State counsel, i.e., Additional Government Pleader Mr.C.Ramar, shall direct [through third respondent] the jurisdictional revenue official to be present in the next listing together with all revenue records, particularly, records pertaining to correlation of old paimash numbers and present survey numbers qua the suit properties.
