## **JUDGMENT**

**WEB COPY** (Judgment of the Court was delivered by **N.SATHISH KUMAR, J.**)

This Writ Appeal is filed challenging the order passed by this Court in W.P.(MD)No.15185 of 2025, dated 26.09.2025.

2. When the matter is taken up for hearing, the learned counsel appearing for the appellant submitted that it would suffice if liberty is granted to the appellant to file an appeal under Rule 121 of the Explosive Rules, 2008.

3. In view of the above, liberty is granted to the appellant to file an appeal under Rule 121 of the Explosive Rules, 2008. Accordingly, the order of the Writ Court is set aside and the appellant is permitted to file an appeal, within a period of one month from the date of receipt of a copy of this order. The appellate authority shall dispose of the appeal on its own merits, without being influenced by the order passed by the Writ Court. The period spent by the appellant before this Court in the Writ Petition and the Writ Appeal shall be excluded for the purpose of filing the appeal.
