### **ORDER**

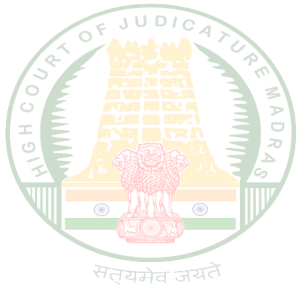
