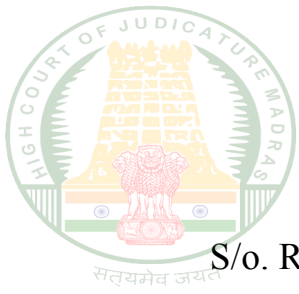

Prayer: Writ Petition is filed under Article 226 of the Constitution of India, praying this court to issue a Writ of Certiorarified Mandamus, calling for the records pertaining to the Impugned Tender Notification dated 17.12.2025 bearing 27 to 32/F. O and M of CWSS/DOII/CW/2025, 33 to 37/F. O and M of CWSS/DOII/CW/2025, and 38 and 39/F. O and M of CWSS/DOII/CW/2025, including the arbitrary, unreasonable, and discriminatory eligibility/qualification criteria prescribed in Performance Based Bid Document for O and M of CWSS in B. Eligibility / Qualification Criteria Sl. No.1, 3, 4, 4.1, 4.2, 4.3, 4.4, 4.5, 4.6 and III. Instruction to Bidders - B. Eligibility / Qualification Criteria Sl. No.6.2 and quash the same, and consequently direct the respondents to re-issue the tender notification in accordance with the prior tender procedures, requirements, and criteria and permit the petitioner to participate in the tender process within such time as may be stipulated by this Court.

ORDER

The challenge in this writ petition is to the Impugned Tender Notification dated 17.12.2025 issued by the 2nd respondent.

2. It is brought to the notice of this Court that similar writ petitions raising identical grounds were filed before the Principal Bench of this Court. A Coordinate Bench of the Principal Bench, by order dated 27.04.2026 in W.P. No.650 of 2026 etc., batch, dismissed all the writ petitions, thereby upholding the validity of the tender conditions and the consequential work orders issued in favour of the successful bidders

3. In view of the fact that the validity of the tender conditions and the consequential work orders has already been upheld by a Coordinate Bench of this Court, no further adjudication survives in the present writ petitions.
