ORDER

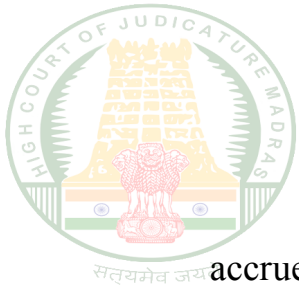
Heard the learned counsel for the petitioner.

2. Issue notice to respondent Nos.1 & 2, returnable by four weeks.

Private notice is also permitted.

3. Issuance of notice to the 3rd respondent is dispensed with, as the appellant has given up the present appeal against the 3rd respondent.

4. Considering the facts and circumstances of the case, this Court is inclined to grant an interim stay till the disposal of the Civil Miscellaneous Appeal in C.M.A.(MD)No.92 of 2026, subject to a condition. Accordingly, an order of interim stay is granted on condition that the petitioner shall deposit the entire award amount, along with
