Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus directing the respondents to issue patta or mutating in the revenue records in the name of the petitioner in Survey Nos.128/1 and 45/1 situated at M.Kovilpatti Village, Singampunari Taluk, Sivagangai District and consider the petitioner's representation dated 15.12.2025.

### **ORDER**

According to the Learned Counsel appearing for the petitioner, the petitioner is in occupation of the said place for 30 years. But the land is classified as "Kanmoi" in the revenue records. The petitioner has obtained an injunction decree in his favour.



However, the respondents submitted that the said place is "Kanmoi". The Kanmoi is a larger extent and a portion of the same has been occupied by the petitioner. But the

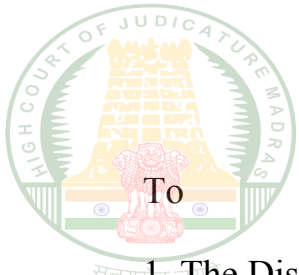
petitioner produced certain photos wherein constructions are there. In fact, National Highways Road is crossing the Kanmoi.

2.In order to ascertain the physical features and topography of the place, this Court is appointing M/s.Priya Dharshini (En.No.5321 of 2025) as an Advocate Commissioner who shall visit the spot and record the physical features and submit a report before this Court. Especially, the Advocate Commissioner shall record whether any concrete constructions are put up in the disputed site and note down the physical features of the site. The Advocate Commissioner shall take the assistance of the Surveyor. The initial fees for the Advocate Commissioner is fixed as Rs.20,000/- and the same shall be paid by the petitioner.
