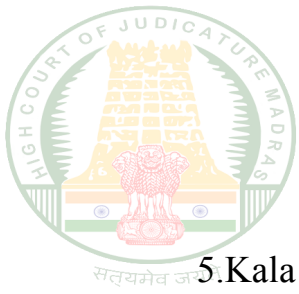

ORDER

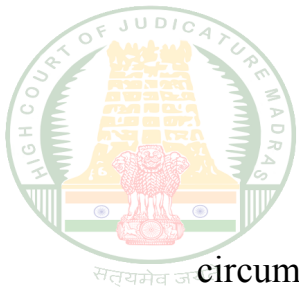

2. Heard the learned counsel appearing for the petitioner. Since the revision is filed for seeking early disposal, no notice is necessary to the respondents 4 to 27.

3. The learned Counsel appearing for the revision petitioners would submit that the petitioner herein / plaintiff has filed the above suit in O.S.No.201 of 2023 on the file of the learned Additional District Judge, Kumbakonam for declaration and permanent injunction and the same is pending for the past 2 years without any progress. He would further submit that the petitioner herein is a senior citizen and therefore, the said case may be disposed of within the time stipulated by this Court.
