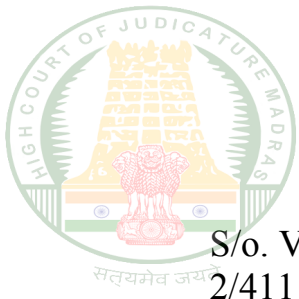

ORDER

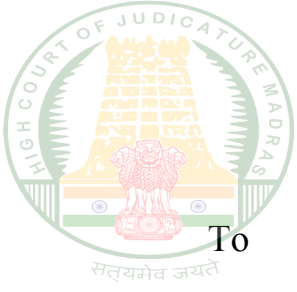
(Order of the Court was made by the Hon'ble G.R.Swaminathan J.)
