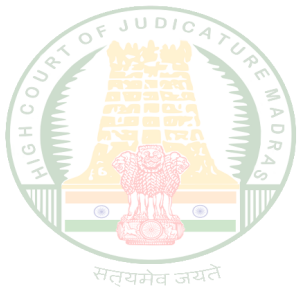

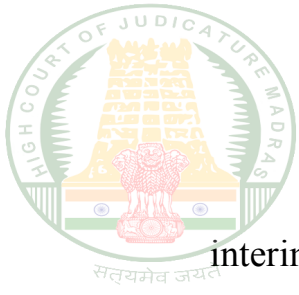

WEB COPY The learned counsel appearing for the revision petitioner submitted that the revision petitioner is a Garnishee and that the direction was issued by the Court below to the Garnishees regarding entitlement to salary, as well as to the revision petitioner who has received the amount from the respondent. While imposing the conditional order of attachment, the variation was calculated at the rate of 24%, which is contrary to the provisions of the Act. Further, according to the petitioner, the interest portion should be 12% only.

2. Heard the learned counsel for the petitioner and the first respondent.

3. Considering the facts and circumstances of the case, there shall be an order of interim stay on condition that the petitioner shall deposit a sum of Rs.50,000/- (Rupees Fifty Thousand only) within a period of four weeks from the date of receipt of a copy of this order, in two equal instalments. In the event of failure to comply with this condition, the

interim stay granted by this Court shall stand vacated automatically
without any further reference to this Court.

4. Notice to the respondents 2 to 5 through Court as well as
privately returnable in four weeks.

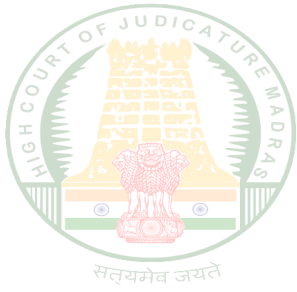
