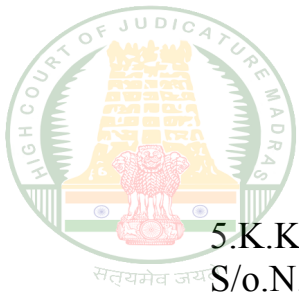

ORDER

The learned counsel for the petitioner / judgment debtor undertakes to deposit a sum of Rs.3,38,865.50, which represents 50% of the amount mentioned in the decree, i.e., of Rs.6,77,731/-, to the decree holder on or before 31.05.2026. He can pay the amount either in one installment or in two installments to the decree holder.

2.Interim order shall operate only as against the petitioner and not as against the other two judgment debtors. Furthermore, if the amount as undertaken by the learned counsel for the petitioner is not paid to the decree holder, the stay granted shall stand vacated even as against the civil revision petitioner. Thereafter, the Executing Court is free to proceed as against the other judgment debtors.
