ORDER

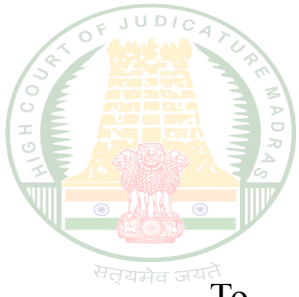
Mr. S. Sivakumar, learned Counsel for the petitioner submitted that the prayer sought for in this Writ Petition has become infructuous.
