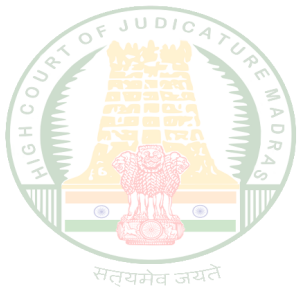

2. Post the matter on 25.10.2025.

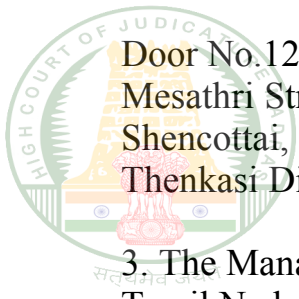
