PRAYER: Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus, directing the respondents 1, 3 and 4 to pay the compensation to the petitioner, by adopting procedures as under the provision of the Right to Fair Compensation Act, 2013 or to grant an alternate site equivalent to the petitioner's property having an extent of 1487 sq.ft. in S.No. 89/3B1B and 3630 sq.ft. in S.No.8/4B2B, and also to pay the compensation for cut off three yielding tamarind trees belong to him, which are illegally grabbed for laying the road.

ORDER

On 08.01.2026, this Court, based on the submissions of the learned Additional Government Pleader, directed that the subject land, over which the road was laid and for which the petitioner claims compensation, be resurveyed in the presence of the petitioner.

2. Though this Court directed that the resurvey be conducted in the presence of the petitioner and that a report be furnished before this Court today, the same has not been complied with by the second respondent.

Therefore, the second respondent / Tahsildar is directed to conduct a survey of the land in the presence of the petitioner within a period of four weeks from the date of receipt of a copy of this order. The second respondent/Tahsildar shall be present along with the resurvey report conducted in respect of the land for which compensation is claimed by the petitioner. List the matter on 04.03.2026.
