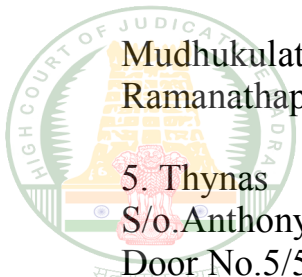

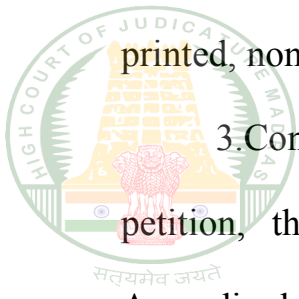
Prayer: To condone the delay of 274 days in re-presentation of the above appeal caused in CMA (MD).SR.No.50120 of 2024.

ORDER
