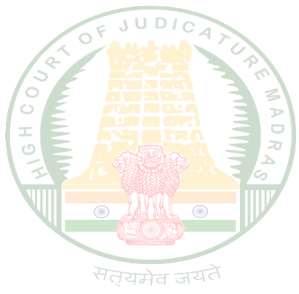

3. Post the matter on **25.03.2026** under the caption “For reporting compliance”.

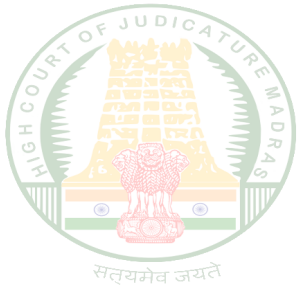
