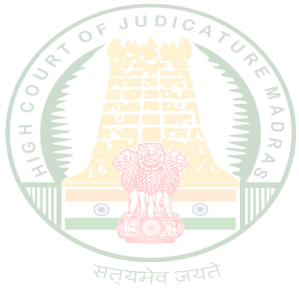

2. In view of the above submission, the police authorities are directed to provide necessary protection to the Municipal authorities to enable enforcement of the order.

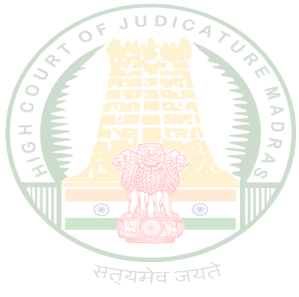
