ORDER

This Civil Revision Petition is filed challenging the fair and decreetal order dated 22.11.2022 made in I.A.No.1489 of 2022 in I.A.No.277 of 2020 in O.S.No.9 of 1915 on the file of the learned Principal District Judge, Madurai.

2. Despite service of notice to the fourth and sixth respondents and their names have also been printed in the cause list, when the matter is taken up for hearing today, there is no representation on behalf of the fourth and sixth respondents. Therefore, this Court thought it fit to appoint a Legal Aid Counsel for the fourth and sixth respondents.

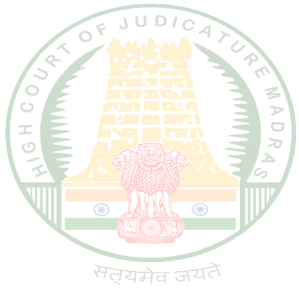
