Prayer: J-36. Civil Revision Petition filed under Article 227 of the Constitution of India to direct the Learned II Additional District Judge at Tiruchirappalli to dispose the O.S.No.226/2024 within the time frame fixed by this Honourable Court and thus render justice.

ORDER

This Civil Revision Petition has been filed seeking for expeditious disposal of O.S.No.226 or 2024 pending on the file of the II Additional District Court, Tiruchirapalli.

2.The petitioner pleaded that the petitioner / plaintiff has undergone medical treatment and he is a senior citizen. Considering the plea, I called upon the learned II additional District Judge, Tiruchirappalli to submit a report as to how long he would require to dispose of the proceedings. The learned II Additional District Judge has submitted a report that the suit is a fit case to be settled by mediation. He has stated that if the parties appear on 23.03.2026 and if he is able to sense an element of settlement between them, he would refer the parties for mediation and make an attempt for settlement through the said process.

3. Ms. Anusha states that the petitioner will appear before the learned II Additional District Judge, Tiruchirappalli on 23.03.2026. The learned II Additional District Judge, Tiruchirappalli shall inform the counsel for the respective parties to ensure their appearance on the aforesaid date. On that date, the learned Trial Judge shall enquire with the parties whether they are willing for mediation and if they are so, he shall refer the matter for mediation.

4. Call this case on 20.04.2026 for further report on the aspect of mediation from the learned II Additional District Judge, Tiruchirappalli.
