ORDER

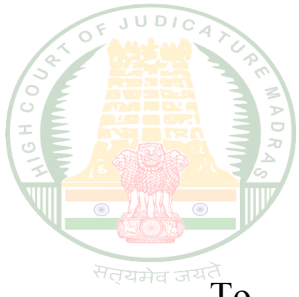
Mr.M.P.Senthil, learned Counsel for Government seeks time to get further instructions on the lay of the land and on the classification of the land in the revenue records.
