(Order of the Court was made by N. ANAND VENKATESH,J.)

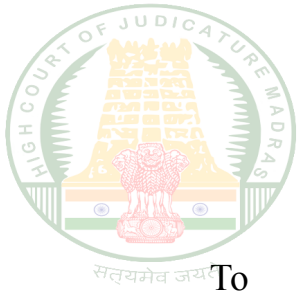
