The first defendant in O.S.No.57 of 2018 on the file of the District Munsif Court, Sivagangai, has filed the present Civil Revision Petition seeking expeditious disposal of the above said suit.

2. A perusal of the records reveal that the suit has been filed for the relief of declaration of title and permanent injunction. When the suit is being posted for trial, the plaintiff has filed I.A.No.7 of 2025 seeking permission of the Court for reception of certain documents. Citing pendency of the interlocutory application, the suit has not been taken up for trial. Hence, the present Civil Revision Petition.
