ORDER

This Civil Revision Petition challenges the order passed by the learned II Additional District Judge, Thanjavur, in CP.No.119 of 2026 in O.S.No.63 of 2024, dated 27.01.2026.

2.I have seen the report of the learned II Additional District and Sessions Judge at Thanjavur, dated 28.04.2026. He has referred to a practice, being followed in that Court, of not issuing certified copies of documents which have not been marked or verified before the Court.

3.The practice followed by the Court is contrary to the view expressed by this court in ***K.Nagarajan Vs. K.S.Ramasamy, (2003) 3 MLJ 211***. A learned single Judge had held that a party is entitled to be granted certified copies of the documents produced by the other side, invoking Rule 127 of the Civil Rules of Practice. When the High Court has declared the law, a practice being followed by the Trial Court that is contrary to the High Court's judgment, has to give way.

4.Hence, following the said judgment, there shall be a direction to the learned II Additional District and Sessions Judge at Thanjavur

to give the unmarked documents relied upon by the plaintiff to the defendants 4 and 5 forthwith.

5.With the above direction, the Civil Revision Petition stands disposed of. No costs.
