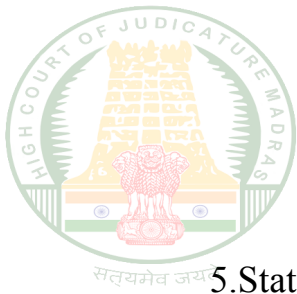

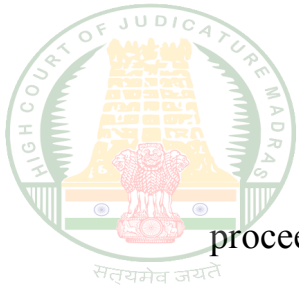

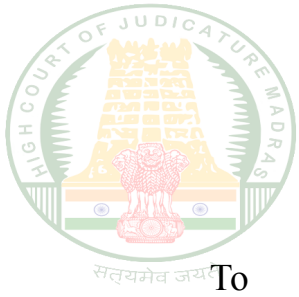
proceeding in G.O.Rt.No.1809 Home, Prohibition and Excise (XII)

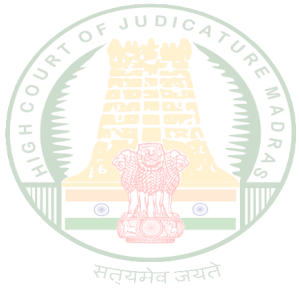
