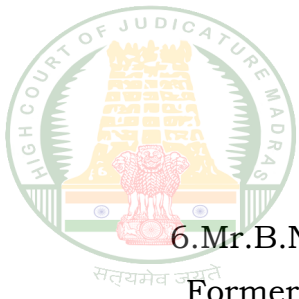

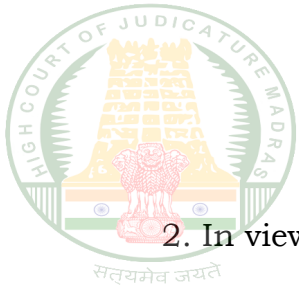

The petitioner, appearing as party-in-person, submitted that although the work order had been issued in her favour, the respondents did not call upon her to execute the agreement. It is further submitted that the work order was subsequently cancelled without assigning any valid reason. According to the petitioner, the reason cited for cancellation is that she, along with her husband, entered the chamber and prevented the Government officials from discharging their duties. The petitioner further undertakes to comply with all requirements necessary for execution of the agreement.
