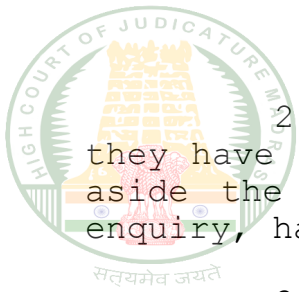

ORDER : This petition coming up for orders on this day, upon perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of Mr.A.MOHAMED HANEEF for Mr.M.P.SENTHIL, Advocate for the petitioner, the Court made the following order:-

The Civil Revision Petition is directed against the order passed in I.A.No.245 of 2019 in O.S.No.159 of 2012, dated 18.02.2021, on the file of the District Munsif Court, Tiruchendur, dismissing the application filed under Order 9 Rule 7 CPC, for setting aside the ex-parte and also the application to reopen the case.
