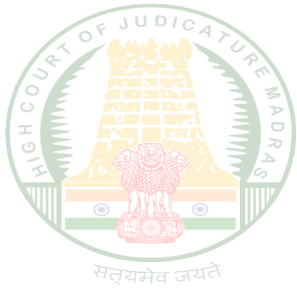
PRAYER in W.P.(MD).No.6443 of 2026: Writ Petition, filed under Article 226 of the Constitution of India, praying this court to issue a Writ of Mandamus, forbearing the 1st to 5th Respondent, their men, officers, representatives from in any manner erecting Transmission Towers/Lines in the Petitioners lands bearing SS.F.No.544/5A4 Kumarapuram Village, Thovalai Taluk, Kanyakumari District and consequently direct the 3rd Respondent to shift the 230 KV Transmissions Towers from the Petitioners land by strictly following the fall in distance fixed by the State Government of Tamil Nadu and the Honble Tamil Nadu Electricity Regulatory Commission and pass such further or other orders.

PRAYER in W.M.P.(MD).No.5376 of 2026: To grant INTERIM INJUNCTION, restraining the 2nd and 3rd Respondent from erecting the 230kv Transmission Towers / Lines near the Petitioners Wind Mill bearing HTSC No. 079204740135 in S.F.No.544/5A4 Kumarapuram Village, Thovalai Taluk, Kanyakumari District, pending disposal of the above writ petition and thus render justice.
