Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus, directing the Respondents No.1 to 3 to restore the Angadimangalan Kanmoi Nadu Madai irrigation channel running through the 4th Respondents land in Survey Nos.122/2A2 and 122/2B2 to the petitioners agricultural fields in Survey Nos. 122/2A1 and 122/2B1 at Angadimangalam Bit - I Village, Madurai East Taluk, Madurai District, and restore its original possession for the petitioners cultivation use by considering her representation dated 09.02.2026 and for other reliefs and pass such further or other orders as this Honble Court may deem fit and proper in the circumstances of the case and thus render justice.

Issue notice of motion returnable by 30.03.2026.

2.Private notice is also permitted to 4th respondent.

3.In the meanwhile, the third respondent, through the jurisdictional Survey Officer shall conduct a field inspection and submit a report as to whether the channel passes through the lands of the 4th respondent and if so, whether there is any danger of effacing the same.
