PRAYER : Writ Petition filed under Article 226 of the Constitution of India praying for issuance of a Writ of Mandamus, to direct the third respondent to consider the petitioner's representation dated 14.08.2025 submitted in respect of issuance of separate patta in favour of the petitioner in respect of the properties comprised in Survey Nos.394/3E, 394/3A and to remove the name of the 7th Respondent in S.No. 394/3F and 394/5B, situated at V. Periyapatti Village,

ORDER

The present Writ Petition has been filed for the issuance of a Writ of Mandamus, directing the third respondent to consider the petitioner's representation dated 14.08.2025, submitted for the issuance of a separate patta in favour of the petitioner in respect of the properties comprised in Survey Nos. 394/3E and 394/5A, and for the removal of the name of the seventh respondent from Survey Nos. 394/3F and 394/5B, situated at V. Periyapatti Village, Manapparai Taluk, Tiruchirappalli District, within a time frame to be fixed by this Court.

2. The petitioner is claiming right over the property in Survey Nos. 394/3E, 394/5A, 394/3F, and 394/5B. It is the contention of the petitioner that the name of the seventh respondent has been erroneously entered in Survey Nos. 394/3F and 394/5B. A larger extent of the property originally belonged to the petitioner as well as to respondents 4 to 7, and there was a partition among them. However,

patta was issued only in respect of the divided portions in favour of respondents 4 to 7. The petitioner claims entitlement to a separate patta for his share, but the official respondents have failed to consider the same. Hence, the petitioner submitted a representation to the official respondents. Based on the petitioner's representation, the second respondent has issued the notice to the Village Administrative Officer, who in turn was directed to conduct an enquiry and submit a report. However, no final order has been passed.

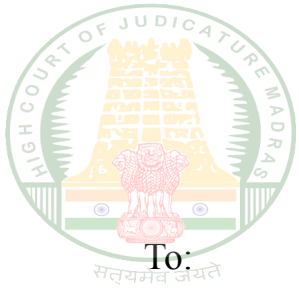
3. In view of the above, the second respondent is directed to conduct an enquiry after issuing notice to the petitioner and the respondents 4 to 7 and pass appropriate order in accordance with law, within a period of four months from the date of receipt of a copy of this order,. Thee petitioner is directed to produce all the relevant documents before the authorities to substantiate his claim.

4. With the above observations, this Writ Petition is disposed of. There shall be no order as to costs.
